In case of Library, Annual activities, Users attendance, New initiatives / implementations, awards, Publications, competition Programmes, Seminar, conference, workshops and MOU's are prepared the reports, with supportive documents should be scanned and preserved for uploading the NAAC portal.

- Web Opac facility, if available screen shots to be uploaded

e-Resources facilities: The librarians should mention whether the following e-resources facilities available in their library;

- e Shodhsindhu
- Shodhganga Membership
- e − Books
- Databases
- Remote access to e-resources

According to the above 6 points, if the institution is Membership in INFLIBNET NList, it will be select points 1,2,4,5 & 6 (excluding Shodhganga – it is applicable for Universities only), other institutions if membership in DELNET they should select points 1,4,5& 6 only.

- Screen shots of the e-resources portals (Logged in status) (INFLIBNET, DELNET, PROQUEST, other e-resources if available)
- e-Resources usage by students, research scholars & faculty - statistical data

Additional key points: Some of the institutions dos't know the e-Shodh Sindhu membership regarding, Incase of e-Shodh Sindhu those institutions have 12(B)and 2(f) of the UGC Act and subscribing NList are entitled to access e-ShodhSindhu.
